Subj :- Grant of Dearness Relief @ 41% of Basic Pension plus Dearness Pension with effect from 1.7.2007 onwards to the Mizoram Government Pensioners and Family Pensioners.

The undersigned is directed to refer to this Department's Office Memorandum No.G.19011/24/2006-F.APF dt.22.5.2007 sanctioning the installment of Dearness Relief from 1.1.2007 and to say that the Governor is pleased to decide that Dearness Relief paid to the Mizoram Government Pensioners and Family Pensioners shall be enhanced from the existing rate of 35% to 41% on Basic Pension plus Dearness Pension with effect from 1.7.2007 onwards on the analogy of the increased rate issued by the Ministry of Personal, Public Grievances and Pensions, Department of Pension and Pensioners Welfare, New Delhi vide their No.42/2/2007-P & PW(G) dt.18.9.2007 in supersession of the rate mentioned above in the Office Memorandum dt.22.5.2007 referred to above.

The enhanced Dearness Relief shall be released and paid in cash to all Pensioners and Family Pensioners of Government of Mizoram from the existing rate of 35% to 41% w.e.f. 1.07.2007 onwards.

Payment of Dearness Relief involving a fraction of rupees shall be rounded off to the next higher rupee.
