- 2. The Server(s) is to be supplied, installed and commissioned in the office of the Director, Institutional Finance & State Lotteries, Department of Finance, Government of Mizoram, Tuikhuahtlang, Aizawl, Mizoram, 796 001 by the Supplier.
- 3. The Server(s) should be backed by a warranty of not less than 3 (three) years with additional 2 (two) years extended warranty.
